#### 1. PRE-ACTION

#### 2. ISSUING A CLAIM AT COURT

We will deal with all aspects of issuing a claim at court, up until the entry of Default Judgment, on a fixed fee basis. Details of our fixed fee for issuing a claim at court are set out in the table below. If your court claim is defended by the debtor, we will provide you with a quote for progressing your court claim to a conclusion, which will be based on the hourly rates set out in the table in section 6 below.

Drafting your claim, issuing it at court and entering Default Judgment	£400	There will be a court issue fee, which will depend on the value of the claim.  For claims with a value up to £10,000, the court issue fee will be between £35 - £455.  For claims with a value between £10,000 and £200,000, the court issue fee will be a sum equal to 5% of the claim value.  For claims with a value of more than £200,000, the court issue fee will be £10,000.

#### 3. ENFORCEMENT OF JUDGMENT

A judgment is an order from the court requiring the debtor to pay you what they owe. If the debtor doesn't pay you, you will be able to take action to enforce the judgment. There are various methods of enforcement available. We will deal with any enforcement action on a fixed fee basis. Details of our fixed fees for enforcement are set out in the table below.
